# Sikua trial progresses

TRIAL into the alleged corruption case against the former permanent secretary of the Ministry of Police, National Security and Correctional Services, Edmond Sikua, continues today.

Prosecution is now in the process of extracting evidence from their second witness after completing their first witness yesterday mid- morning.

The first witness is the Chief Infrastructure Officer of the Ministry of Police, National Security and Correctional Service, Christine Suri (MPNS& CS).

gave evidence on Tuesday and was cross examined yesterday by the

Prosecution has a total of 26 witnesses.

They are witnesses from the MPNS& CS, officers from Police Infrastructure Department and Accounts Department, some police officers from Hells Point and a witness from the

Leadership Code Commission (LCC).

Sikua is facing seven counts of official corrup-

Prosecution alleged he awarded government tenders worth \$630.436.50 to Beeds Investment on 22 December 2016, a company registered and owned by his two daughters.

Prosecution alleged that as permanent secretary, Sikua is by default the chairman of his ministry's tender board.

It was alleged that be-

tween 18 December 2015 and 29 August 2016, Beeds Investments responded to calls for tenders and was awarded business tracts for service delivery to the Ministry of Police, National Security and Correctional Services on seven different occasions.

The Ministry of Po-ce, National Security lice, and Correctional Services have made payments of \$630,436.50 to Beeds Investments for these services.

Prosecution further alleged that Sikua used his position of power and influence within the Ministry of Police, National Security and Correctional Services to manipulate the tendering process for his own and his family's pecuniary advantage.

Sikua is the third public officer to have been arrested by Janus, since the establishment of the joint taskforce in August 2016.

He is represented by Gabriel Suri, of Suri's Law Practice, while Public Prosecutor Bradley Dalipanda appears for the

So far, three witnesses have given evidence into the death of George Kallis from Melbourne, on 27 Feb-

One of those witnesses is the doctor who attended to the deceased, giving medical evidence.

He concluded that, Kallis has died as result of an electrocution.

The expat was said to have died from an electric shock, while attempting to charge a battery in the ship, while it was berthing.

One of the witnesses is a forensic officer involved in this case, while another is the deceased's employee and friend.

The Coroner in this inquiry is Principal Magistrate, Augustine Aulanga.

## PM Hou on rebranding

PRIME Minister, Rick Hou, says that re-branding is a necessary marketing platform that draws in and connects not only every visitor to the Solomon Islands but more so, connects every Solomon Islander to our country.

But this rebranding marketing platform requires the whole of government acting together.

He said that as part of our nation-building, all sectors must align their development programmes and activities that are meaningful and relevant to the people of this country.

PM Hou said that the tourism sector is taking the lead in aligning the tourism brand to the country and its people.

### Solomons seeks stronger links with PNG

SOLOMON Islands and Guinea New should strengthen socioeconomic links in light of growing foreign commercial interests in the region, Solomon Islands Commissioner Barnabas Agna says.

"There may be times when we are driven by emotions, but the most-important thing is to take a step back and think of our people's interests.

"That should be the guiding factor for each of us as well for greater coop-

"Our people should be a priority point, whether it be commercial considerations or dealing with others who are coming into the region," he said.
